



## 2022 CONVENTIONAL 4-POSITION SMALLBORE RIFLE JUNIOR SECTIONAL

APRIL 2, 2022

### AMARILLO RIFLE AND PISTOL CLUB AMARILLO, TEXAS

**LOCATION:** Amarillo Rifle & Pistol Club, 7650 N. Western, Amarillo, TX. Take the Western Street exit (#67) off I-40 and go north on Western Street. The range is located 2.2 miles North of Loop 335.

**REGISTERED MATCH:** NRA membership is not required for entry in this match. If you are a member, please include your membership number on your scorecard for classification purposes.

**RULES:** Current NRA Smallbore Rifle Rules will govern.

**SCORE CARDS:** Special NRA Team and Individual score cards will be used. If no category is indicated, the team/individual will be placed in the Junior category. For those of you who only shoot on 4-H Teams, the categories you normally use don't apply in this match. Please use the category that applies to your age under Individual Categories listed below.

**INDIVIDUAL MATCH:** Open to any individual who meets the eligibility requirements of NRA Rule 2.3.

**INDIVIDUAL CATEGORIES:** (Only one category may be entered)

Junior: Anyone can compete as a junior thru Dec 31<sup>st</sup> of the calendar year in which he/she turns 20.  
Intermediate Junior: A junior may compete as an intermediate junior until Dec 31 of the calendar year in which he/she turns 17.  
Sub-Junior: A junior may compete as a sub-junior until Dec 31 of the calendar year in which he/she turns 14.  
Military Scholastic: Active member of a high school JROTC unit or enrolled in a military high school. NRA Rule 2.9.1.

**ENTRY FEES:** Individual entry fees - \$15.00. Team entry fees - \$10.00 per team.

**DISTANCE FIRED:** Fifty feet

**RIFLE:** Rule 3.2, Any Rifle

**POSITIONS:** Rules 5.6, 5.10 and 5.12.

**SIGHTS:** Rule 3.7(a) Metallic Only.

**SIGHTING SHOTS:** Unlimited number of sighting shots are permitted, but all shots fired (sighters and record) must be fired within the time allowed for record firing.

**TEAM MATCHES:**

Open to any club who meets the eligibility requirements of NRA Rules 2.3 and 2.11(a). Individuals may fire on only one team and one sectional.

A team will consist of four (4) firing members representing a club affiliated with NRA (Rule 2.11). A team composed of shooters who are not all in the same age category is a mixed team and will enter in the age category of the oldest member.

**TEAM CATEGORIES:**

**Teams MUST meet Rule 2.11 and PRACTICE together on a regular basis as well as shoot tournaments together. NO PICK-UP TEAMS ARE ALLOWED! "Team Only" entries will not be allowed.**

Junior: Teams comprised wholly of members who are eligible under Rule 2.3 and belong to the same club.  
Intermediate Junior: Teams comprised wholly of members who are eligible under Rule 2.3.1 and belong to the same club.  
Sub-Junior: Teams comprised wholly of members who are eligible under Rule 2.3.2 and belong to the same club.

Scholastic: Teams comprised wholly of members attending the same school and belonging to the school-sponsored club (Rule 2.17).  
Military Scholastic: Teams comprised wholly of Military Cadets from clubs representing military schools, military cadet organizations, of Junior ROTC units (In order to be eligible to shoot on a JROTC Team, an individual must have entered in the JROTC individual category).

**FIRING TIME:** 2:00 PM. We have 12 firing points. If a second relay is needed firing time will be 3:30 PM.

**COURSE OF FIRE:** All Matches will be fired using Orion Scoring System 50m targets reduced for 50 ft.

**PLEASE NOTE THESE ARE NOT ELECTRONIC TARGETS!**

**Coaching will not be allowed (Rule 9.10).**

MATCH 1: 10 shots prone, 1 minute per record shot.  
MATCH 2: 10 shots standing, 1 ½ minutes per record shot.  
MATCH 3: 10 shots sitting, 1 minute per record shot.  
MATCH 4: 10 shots kneeling, 1 minute per record shot.  
MATCH 5: Sectional Individual 4-Position Smallbore Rifle Championship (An aggregate of Matches 1, 2, 3 and 4).  
MATCH 6: Sectional Team Conventional 4 Position Championship (Paper Match). This is an aggregate of each team member's scores from Match 5. National Records may be awarded.  
MATCH 7: National Conventional 4 Position Smallbore Rifle Championship. Scores are from Match 5.  
MATCH 8: National Team Conventional 4 Position Smallbore Rifle Championship. Scores are from Match 6.

**TIE SCORES:** Ties will be broken using NRA Rule 15 for individual matches and NRA Rule 15.8 for team matches.
